Themes we'll be covering in our response

- Financial barriers
- The lack of a guaranteed route to market for generation projects and revenue support – 5MW + projects have Contracts for Difference.
- Funding for the risky development phases of community energy projects
- Lack of consistent funding for energy efficiency retrofit – feast or famine
- Block on community energy groups offering flexibility





Non-Financial barriers

- Inability of local generators to sell electricity to their local communities
- Lack of support eco-systems needed to enable community energy activities to come forward
- De-prioritisation of community energy
- Planning National planning policy neglects the overriding importance of renewables – the basis of our future economy / society
- Community energy proposals seen as buying planning permission





Non-Financial barriers (cont)

- The continued block on onshore wind
- Grid infrastructure high connection costs, lack of capacity. Delay.
- Lack of diversity in community energy sector
- Access to data national dataset of renewable energy capacity - wind, solar, grid capacity. Solar Wizard





Co-benefits of community energy

- Routes to engaging people in climate action making it locally relevant
- Building carbon and energy literacy and informed consent to expand renewables
- Building local resilience + self sufficiency
- Delivering renewables where the market could / would not





Tips for responding

- Tell your truth, and the barriers you've faced succinctly. Provide a snappy summary if needed
- No need to respond to all the questions
- Provide solutions, not just problems what do we want a possible labour government to be thinking about re: support structures + changes?
- Back up with evidence where possible
- Don't just concentrate on renewables, also energy efficiency retrofitting, and energy flexibility





Tips

- Recognise that the Feed in Tariff won't be returning, but that a route to market is needed
- How can the community energy sector be more representative of wider society?
- Mindset in a time of austerity, how to convince the treasury (even a labour treasury) that community energy is worth investing in
